2. Complete the Notice of Address

- a. The Registered Office address and Records address MUST be a street address or legal land location ONLY
- b. If a legal land location is provided for the above, you MUST provide a PO Box for mailing
- 3. Complete the Name Search Request (if applicable)
 - a. A Nuans Report is required for Named Corporations only
 - b. Numbered Corporations will be assigned a number. Fill in *Alberta Ltd., or Alberta Inc. or Alberta Corp.* in the Chosen Name field
